**Notice of Cancellation of WEIM Implementation Agreement with the
Public Service Company of Colorado**

Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO) submits for Commission acceptance this notice of cancellation of the Western Energy Imbalance Market (WEIM) Implementation Agreement between the CAISO and the Public Service Company of Colorado (PSCo) (Implementation Agreement).¹ The CAISO is cancelling the Implementation Agreement in accordance with its terms, because the parties have mutually agreed to termination.

The CAISO requests that the Commission accept this notice of cancellation effective 61 days after the date of this filing, *i.e.*, April 19, 2022.

I. Background and Basis for Cancellation

In 2020, the Commission accepted for filing the CAISO's submittal of the Implementation Agreement and granted the CAISO's requested effective date of July 31, 2020.²

Section 2(a) of the Implementation Agreement states that parties may mutually agree to terminate the agreement in writing at any time, which the parties have done. Further, Section 2(g) acknowledges that the Implementation Agreement shall terminate upon Commission acceptance of a notice of termination. Therefore, the CAISO requests
