**Informational Filing - Effective Date of Clarification on Intertie  
Deviations Tariff Amendment**

Dear Secretary Bose:

On February 22, 2022, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to address three issues with the “Under/Over Delivery Charge,” which is a charge the CAISO assesses for deviations from scheduled intertie transactions. By order issued April 26, 2022, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementing the tariff changes.<sup>1</sup>

The CAISO implemented the tariff changes for Intertie Deviations tariff amendment on June 1, 2022. Accordingly, the CAISO is submitting this informational filing to specify an effective date of June 1, 2022 for the tariff revisions accepted by the Commission in this docket.<sup>2</sup>
