**Informational Filing of Effective Date of EIM Base Schedules Below
Minimum Load**

Dear Secretary Bose:

On August 3, 2021, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to allow participants in the Energy Imbalance Market (EIM) to submit EIM base schedules below the minimum load of their resources. The CAISO proposed an effective date of November 1, 2021, subject to confirmation by the CAISO within five business days of the actual effective date. By order issued October 29, 2021, the Commission accepted this tariff amendment and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO implemented the tariff changes for EIM base schedules on November 1, 2021. Accordingly, the CAISO is submitting this informational filing to specify an effective date of November 1, 2021 for the tariff revisions accepted by the Commission in this docket.²

The CAISO has served copies of this filing on all the parties to the service list for this proceeding. In addition, the CAISO is posting this filing on the CAISO website.
