**Re: California Independent System Operator Corporation**

**Informational Filing of Tariff Amendment to Adjust Shift Factor  
Threshold and Enhance Market Parameter Change Process**

Dear Secretary Bose:

On May 31, 2023, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment in this proceeding to (1) adjust the threshold it applies for considering the effectiveness of a resource in managing congestion, and (2) propose a new process to permit temporary changes to parameter values the CAISO market uses to reflect relative scheduling priorities and constraints. By order issued August 24, 2023, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.<sup>1</sup>

The CAISO implemented the tariff changes for the Market Parameter Change Process initiative on September 13, 2023. Accordingly, the CAISO is submitting this informational filing to specify an effective date of September 13, 2023 for the tariff revisions accepted by the Commission in this docket.<sup>2</sup>

<sup>2</sup> Specifically, this informational filing updates the effective date for all Tariff Records submitted in the initial filing and compliance filing to September 13, 2023. The CAISO is submitting the informational filing in eTariff using Type of Filing Code 150. The August 24 Order also called for the CAISO to submit a compliance filing. The CAISO is submitting that filing under separate cover with the impacted tariff provisions also having an effective date of September 13, 2023.
