On September 29, 2023, California Independent System Operator Corporation submitted revisions to the Grid Management Charge in its Open Access Transmission Tariff to revise the System Operations Charge and to include a temporary Extended Day-Ahead Market charge.<sup>1</sup> Pursuant to authority delegated to the Director, Division of Electric Power Regulation – West, under 18 C.F.R. § 375.307, the submittal is accepted for filing, effective as requested.

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission’s regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed document(s); nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against applicant(s).

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
