

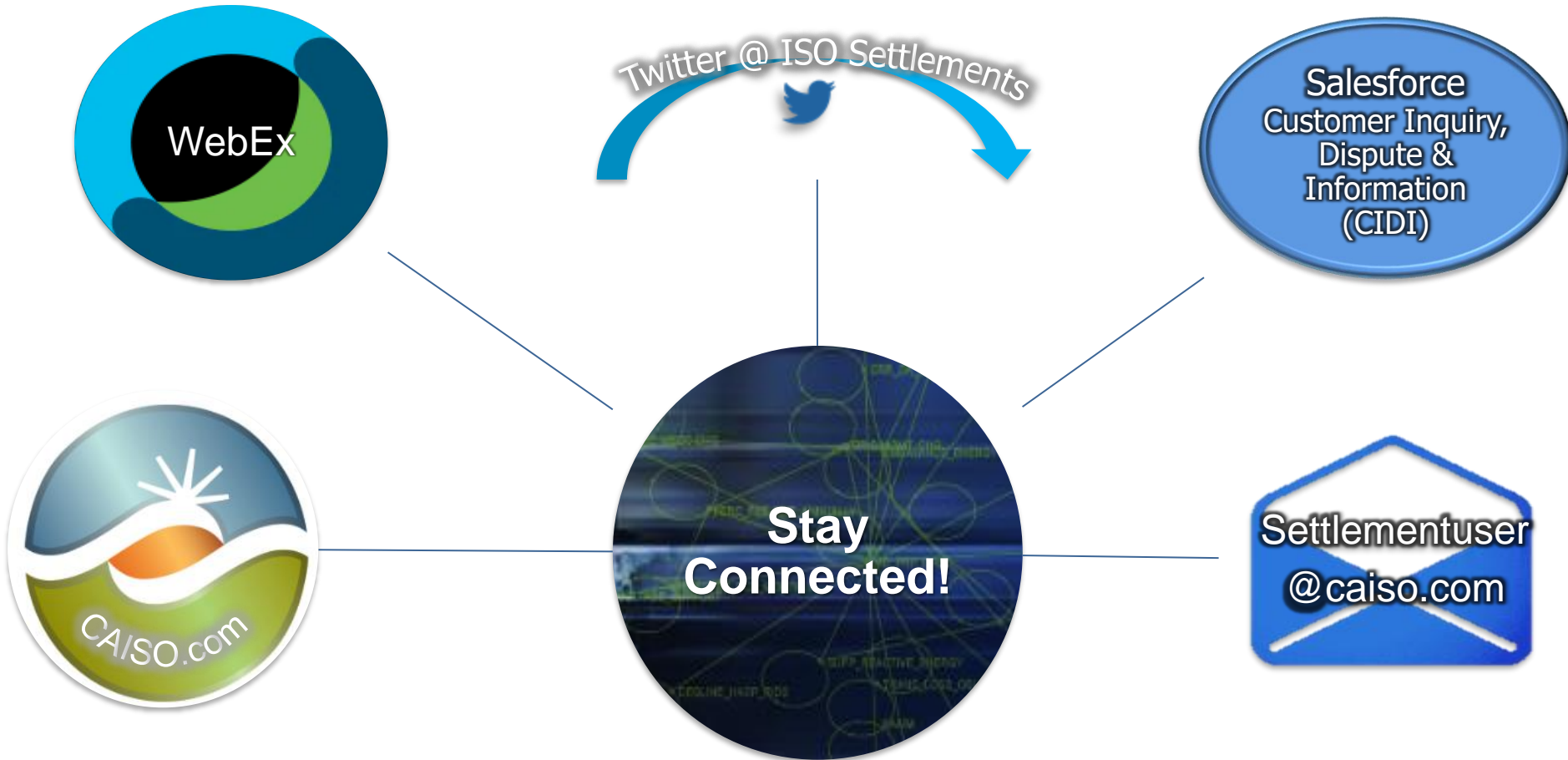

Unscheduled Directed Recalculation Statements and Invoices

- On Dec. 9, 2021, the California ISO will publish unscheduled directed recalculation settlement statements reflecting the resolution of a dispute with a market participant. On the same day, the ISO will issue separate invoices for these amounts with a payment due date of December 15.
- A calendar reflecting the revised publication date, review period and invoicing is available on the ISO website at <http://www.caiso.com/market/Pages/Settlements/Default.aspx> under the *Retroactive settlements > Recalculation settlements > Unscheduled directed* subheading.
- The settlement files will be available under run type Daily Rerun Market trading dates Oct. 10, 2012, and Feb. 16, 2018. The details for October 10, 2012 will be in the comment field of the bill determinant file. Customer Service will provide the details for February 16, 2018, to affected market participants. Any disputes of charges appearing on the unscheduled directed recalculation settlement statements must be submitted by **Wednesday, January 12, 2022**.

NERC/WECC Invoice

- The ISO published preliminary NERC/WECC statements and invoices for 2022 NERC/WECC charges to the Market Results Interface-Settlements (MRI-S) and the Secure File Transfer Protocol (SFTP) server on August 20, 2021. The charges for assessment year 2022 appear on the NERC/WECC initial statement under charge code (CC) 6490, with January 1, 2020 as the trade date.
- The preliminary NERC/WECC charge rate for assessment year 2022 is provided below for scheduling coordinators' information pursuant to ISO Tariff section 11.20.4.


