ESDER 2 DRRS – Batch Submission Recommendation

- When a DRP submits a batch to DRRS, the batch status can have 4 possible values for: SUCCESS, ERROR, IN_PROCESS, and NOT_PROCESSED
- Once the batch is submitted, the status is set to "NOT_PROCESSED". The processor runs periodically to pick up the submitted batch jobs and start processing them by changing the status to "IN_PROCESS".
- Depending on the result of the batch validation process, the status will then change to "SUCCESS" or "ERROR".

ESDER 2 DRRS – Batch Submission Recommendation

- As part of the ESDER 2 project go-live, the DRPs are required to terminate all existing registrations and submit new registrations using the new baseline methods with an effective start date of 11/01/2018.
- DRPs are required to submit these new registrations in DRRS from 10/15/18 to 10/31/18 in order to avoid any gap in registrations.
- To ensure a smooth processing of these batch files and in order to avoid over loading the DRRS application, the ISO is requesting the DRPs to follow these guidelines:
 - Limit new batch submissions to 10,000 locations per batch
 - Do not submit duplicate data sets as the system will have to process through the same information multiple times.
 - Ensure there is a delay in the submission of the batches as the batches are queued for processing.



ESDER 2

MRI-S CBL and TMNT Data submission with Registration ID

- As part of the ESDER 2 project go-live, the DRPs are able to submit CBL and TMNT data along with Registration ID. However this data can be submitted using only XML format.
- We will not be supporting CSV Files to submit CBL and TMNT data with Registration ID.
- Technical Specifications Documents will be updated and published with this information.
