



Each year the ISO publishes a stakeholder initiatives catalog.

- Its main purpose is to
 - Document initiatives proposed over time by ISO and stakeholders
 - Communicate initiatives ISO considers high priority and will conduct stakeholder processes on during upcoming year
- Initiatives can fall into four different categories
 - In progress (I)
 - FERC-mandated (F)
 - Non-discretionary (N)
 - Discretionary (D)

Nine initiatives have been completed in 2015.

- 9. Natural Gas Pipeline Penalty Recovery

13 stakeholder initiatives are currently underway.

INITIATIVES TO BE STARTED



Five new initiatives are planned to start in Q4 of 2015.

- 1. Stepped Constraint Parameters
- 2. Two-Tier Allocation Real-Time Bid Cost Recovery
- 3. Fifteen-Minute Market Intertie Liquidity
- 4. Regional Transmission Access Charge Structure
- 5. Resource Adequacy Rules



Six new initiatives are planned start in 2016.

- 1. Regional Integration California Greenhouse Gas Compliance
- 2. Metering Rules Update
- 3. Full Network Model Enhancements
- 4. Real-Time Market Enhancements
- 5. Generator Contingency Modeling/Remedial Action Scheme Modeling
- 6. Transitional Implementation Items



For this year's cycle of the catalog, will not go through an initiative ranking process.

- ISO is currently scheduled with 20 initiatives in 2016
 - Seven initiatives are projected to finish by end of Q1 2016
 Six initiatives will address regional expansion policies
- Due to high volume of initiatives already planned, there is no room for additional discretionary initiatives resulting from a ranking process
- ISO welcomes stakeholder comments on catalog, as well as suggestions for items to be added to catalog for consideration as potential initiatives
