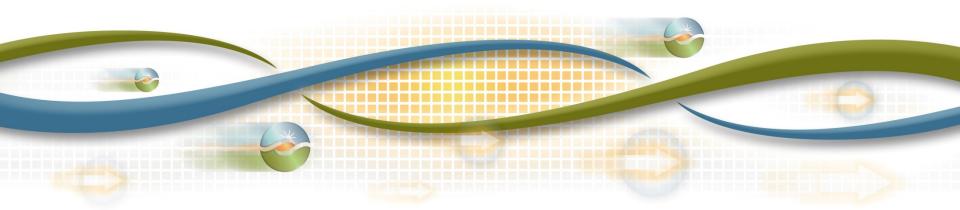

Replacement Requirement

- Contract ID should be unique on the RA plan
 - Replacement requirement is miscalculated when contract ID is reused between a designated resource and a specified replacement resource
- Question on holding off on reporting outage changes until T-11
