

Overview of changes since straw proposal

- Expanded policy initiative catalog process
  - Revised stakeholder submission template
  - Revised catalog categorizations
    - In Progress (I), FERC (F), ISO-Committed (C), Discretionary (D)
  - Added deadline for stakeholder submission template
    - First Tuesday of January and July
  - Added stakeholder comment period
    - After deadline for submissions, market participants will have 2 weeks to review and provide comments.
- No changes to annual policy initiatives roadmap process



## STAKEHOLDER COMMENTS ON STRAW PROPOSAL



### Proposal to use stakeholder comment template

- APS, BANC, Idaho Power, NV Energy, PacifiCorp, PGE, Powerex Corp., Puget Sound Energy, Seattle City Light, and Salt River Project, LSA, NRG, Six Cities, and XO Energy support this proposal
  - Stakeholder comment period necessary for every submission
  - LSA, Modesto Irrigation District, PG&E CAISO needs to have deadlines for submissions
  - LSA and CMUA ISO should send a Market Notice when new submissions come in
- No opposition stated in comments

CAISO has changed its proposal based on stakeholder feedback and revised its proposal to include a cutoff date for submissions and a stakeholder comment period.



### Proposal to have catalog posted in Feb and Aug

- APS, BANC, Idaho Power, NV Energy, PacifiCorp, PGE, Powerex Corp., Puget Sound Energy, Seattle City Light, and Salt River Project, LSA, Modesto Irrigation District, PG&E, Six Cities, WPTF, and XO Energy support this proposal
  - Support contingent upon stakeholder comment period being introduced
- No opposition

CAISO has changed its proposal based on stakeholder feedback. The ISO post a draft catalog at the beginning of Feb and Aug and request stakeholder comments. A final catalog will be posted at the end of Feb and Aug.



### Proposal to revise discretionary sections of catalog

- Neither supported or opposed by stakeholders
- **Six Cities** Classification of non-discretionary and discretionary initiatives needs to be revisited
  - Should be changed to substantial and time-sensitive reliability concern

CAISO has eliminated the "non-discretionary" classification and added the "ISO-committed" and clarified its definition. "ISO-committed" classification consists of initiatives that the ISO has committed to during a regulatory proceeding or previously to stakeholders, the ISO Board, EIM Governing Body, or FERC.



### Proposal of timeline for new annual plan

- **PGP opposes** the annual plan only being updated once a year
  - Clarified previous comments and reiterated the need to have a reevaluation in May should take place.
    - Make any necessary adjustments for the rest of the year

CAISO provides bi-monthly updates to the annual plan during the Market Performance and Planning Forum (MPPF), through quarterly policy briefings at EIM Governing Body meetings, and on the initiative milestones document on the stakeholder process website.



### Proposal to retire formal numerical ranking process from roadmap process

- APS, BANC, Idaho Power, NV Energy, PacifiCorp, PGE, Powerex, PSE, SCL, Salt River Project, CMUA, LSA, Modesto Irrigation **District, NRG, PGP, PG&E, and Six Cities** generally support this proposal
  - **CMUA** "While well intentioned, it had the opposite effect than that intended and precipitated stakeholder attempts to game the ranking. CMUA applauds the CAISO for removing this mechanism"
- **Financial Marketers Coalition, WPTF, and XO Energy** oppose this proposal
  - Another mechanism needs to replace ranking so stakeholders can express their support justification for certain initiatives

CAISO recommends no change to its proposal. The new proposal provides stakeholders the opportunity to provide specific feedback on the CAISO's proposed three-year roadmap and annual plan justifications.



Proposal to publish 3-year market vision

- APS, BANC, Idaho Power, NV Energy, PacifiCorp, PGE, Powerex Corp., Puget Sound Energy, Seattle City Light, Salt River Project, CMUA, LSA, Modesto Irrigation District, NRG, PG&E, PGP, Six Cities, WPTF, and XO Energy support this proposal
  - PGP: "believes this will provide important context and a sense of continuity to the Policy Initiative planning process"
- No opposition

CAISO recommends no change to its proposal. The new process will provide more meaningful and forward thinking conversations with all stakeholders.



### Proposal for development of annual plan

- APS, BANC, Idaho Power, NV Energy, PacifiCorp, PGE, Powerex Corp., Puget Sound Energy, Seattle City Light, Salt River Project, LSA, Modesto Irrigation District, NRG, PG&E, PGP, Six Cities support this proposal
- PGP- other criteria besides cost/benefit should be included
- Financial Marketers Coalition, WPTF, and XO Energy oppose this proposal
  - Does not give stakeholders the opportunity to participate in the development of the process

CAISO recommends no change to its proposal. CAISO not only takes into consideration cost and benefits, but implementation considerations as well. Additionally, stakeholders have always had the opportunity to participate and provide comments in the development of the roadmap. Stakeholder comments are taken into consideration in the CAISO's justification for the annual plan.



Annual Policy Initiatives Roadmap Process

Step 1: Revise policy initiatives catalog

- Template for external and internal stakeholders submissions
- Revised two times a year (Feb & Aug)
  - 1. Deadline to submit submissions first Tuesday of January and July
  - 2. Stakeholder review/comment period
  - 3. Publish final policy initiatives catalog



Annual Policy Initiatives Roadmap Process continued

Step 2: Publish draft three-year policy roadmap and annual plan in September

- 1. Stakeholders comments period
- 2. If necessary, revision to draft three-year policy roadmap and annual plan
- 3. Stakeholder comments period
- Publish and present final three-year policy roadmap and annual plan to EIM Governing Body and Board of Governors in December

#### Annual policy initiatives roadmap process

The annual roadmap process captures the policy initiatives the ISO will undertake in the following year and their approximate timeframes. The catalog, updated twice a year, is a comprehensive directory of current, planned and potential policy initiatives that require a stakeholder process.







### Three-year market vision roadmap example









New process focuses on improving efficiency and transparency

- More transparency to stakeholders
  - External and internal submissions to catalog are visible to all stakeholders
  - Gives more transparency to the CAISO's rationale and timing of initiatives
- Stakeholders provide input into the CAISO planning process for the next three years
- Three-year policy roadmap provides better visibility into alignment of policy and implementation schedules
