

PSE has recently executed an EIM Implementation Agreement with the ISO and looks forward to becoming the third EIM Entity to join the EIM. On behalf of PSE, I express my appreciation for the work conducted by the ISO and the Transitional Committee to date to progress the opportunities for increased reliability and reduced costs created by the EIM.

My proven leadership skills, work on diverse and complex issues concerning the regional energy industry, and interest and willingness to serve on the Transitional Committee, fulfill the qualifications outlined in the Charter and support my appointment as the next Transitional Committee Member. When I joined PSE in 2002, I was the director of Energy Supply & Planning, responsible for power and natural gas trading, generating plant dispatch, merchant transmission issues, and the company's long-term

integrated resource planning. My team also managed integrating renewable resources in to PSE's generation portfolio. Prior to joining PSE, I was the trading floor manager for the Bonneville Power Administration.
