Dear Secretary Salas:

On April 13, 2006, the California Independent System Operator Corporation ("CAISO") submitted an informational filing pursuant to Article IX, Section B of the Stipulation and Agreement approved by the Commission on May 28, 1999, *California Independent System Operator Corp.*, 87 FERC ¶ 61,250 (1999). Article IX Section B of the Stipulation and Agreement requires the CAISO to provide on a confidential basis to the Commission (i) information regarding any notice from a Reliability Must Run ("RMR") Unit¹ requesting a change of Condition; (ii) the date the chosen Condition will begin; and (iii) if the change is from Condition 2, the applicable level of the Fixed Option Payment.

The confidential information was provided in Attachment A and was submitted under seal clearly marked as **CONFIDENTIAL**. It has come to the CAISO's attention that Attachment A contained incorrect information. Accordingly, the CAISO hereby submits an original and 14 copies of this supplemental informational filing. These copies include a redacted version of Attachment A. The CAISO is also submitting one copy marked **CONFIDENTIAL**, which has a non-redacted version of the corrected version of Attachment A. Two additional copies of this filing are enclosed. Please date-stamp them and return them in the self-addressed prepaid Federal Express envelope.

As required by Article IX, Section B of the Stipulation and Agreement, the CAISO has provided this information described above (subject to the applicable Non-Disclosure and Confidentiality Agreement in the RMR Contract) to the designated
