**Re: California Independent System Operator Corporation**

**Informational Filing of Effective Date of Revised Adjacent  
Balancing Authority Operating Agreement**

**Docket No. ER20-1514-000**

Dear Secretary Bose:

On April 8, 2020, the California Independent System Operator Corporation (CAISO) filed in this proceeding a revised Adjacent Balancing Authority Operating Agreement (ABAOA) between the CAISO and Nevada Power Company (NEVP), doing business as NV Energy. The revisions to the ABAOA reflected the planned interconnection of the 500 kV transmission line from NEVP's Harry Allen Substation (Harry Allen) to the Eldorado Substation (Eldorado), in order to create a new intertie between NEVP's balancing authority area and the CAISO's balancing authority area. The CAISO requested an effective date of April 30, 2020 for the ABAOA revisions, because that was the anticipated energization date for the facilities that would establish the Harry Allen to Eldorado intertie. However, the CAISO also explained that energization of the facilities could possibly occur on a date after April 30, in which case the CAISO requested that the Commission direct the CAISO to submit a further filing to revise the effective date of the ABAOA revisions.<sup>1</sup>

By letter order issued May 21, 2020, the Commission accepted the ABAOA revisions effective April 30, 2020 as requested by the CAISO, noting that if the CAISO requires a later effective date for the ABAOA revisions in the event

that the facilities are energized after April 30, the CAISO must make a further filing to specify that effective date.

The facilities were energized on August 12, 2020. Accordingly, the CAISO is submitting this informational filing to specify an effective date of August 12 for the ABAOA revisions accepted by the Commission in its May 21, 2020 letter order.<sup>2</sup>

The CAISO has served copies of this filing on all the parties to the service list for this proceeding. In addition, the CAISO is posting this filing on the CAISO website.
