On June 28, 2019, the California Independent System Operator Corporation (CAISO) filed a non-conforming Reliability Coordinator Services Agreement with Los Angeles Department of Water and Power (LADWP) providing for a finite term of service of 30 months.¹ Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted,² and the Agreement is accepted for filing, effective July 1, 2019, as requested.

This filing was noticed on June 28, 2019, with comments, protests, or motions to intervene due on or before July 19, 2019. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.
