Informational Filing and Request for Privileged Treatment**

Dear Ms. Bose:

The California Independent System Operator Corporation submits this informational filing, pursuant to the January 4, 2013 order of the Federal Energy Regulatory Commission approving the Reliability Must-Run Agreement for synchronous condensers at AES Huntington Beach Generating Station Units 3 and 4 (“RMR Agreement”)¹, and the May 1, 2014 order granting modification of the reporting schedule; accepting the CAISO’s proposal to submit reports by the tenth day following the end of each subsequent three-month period of operations.² In accordance with the January 4, 2013 and May 1, 2014 orders, the CAISO submits its report for the months of September 2017, October 2017, and November 2017; attached as Appendix A.

The CAISO is seeking privileged treatment of Appendix A pursuant to 18 C.F.R. Section 388.112 and Article 5.5 of the RMR Agreement. Article 53.5 of the RMR Agreement requires the RMR owner, on a monthly basis, to provide the CAISO and the Responsible Utilities certain information, including the “Counted Service Hours,” and requires the CAISO to treat this information as confidential.
