MOTION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION FOR EXTENSION OF TIME TO FILE CORRECTED ELECTRIC QUARTERLY REPORTS, AND REQUEST FOR EXPEDITED ACTION

Pursuant to Rules 212 and 2008(a) of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. §§ 385.212, 385.2008(a), the California Independent System Operator Corporation ("CAISO") respectfully requests an extension of time to submit its corrected First Quarter, Second Quarter, and Third Quarter 2005 Electric Quarterly Reports ("EQRs") by February 28, 2006, after it has had the opportunity to absorb the guidance provided by the Commission's December 14, 2005, EQR Users Group teleconference regarding clarification of the technical compliance reports provided to the CAISO on November 29, 2005. In support of this motion, the CAISO states as follows.

I. Statement of Issues

Pursuant to Rule 203(a)(7) of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.203(a)(7), as modified by Commission Order No. 663 (FERC Stats. & Regs. ¶ 31,393 (2005)), the CAISO hereby provides the following statement of the issues to be decided:

Whether the Commission should, on an expedited basis, grant the CAISO an extension of time until February 28, 2006, to make the required submittals of its corrected First, Second, and Third Quarter 2005 EQRs.

II. Background

On April 25, 2002, Commission issued Order No. 2001,¹ amending its filing requirements under the Federal Power Act to require public utilities to electronically file EQRs summarizing the contractual terms and conditions in their agreements for all jurisdictional services (including market-based power sales, cost-based power sales, and transmission service) and transaction information for short-term and long-term market-based power sales and cost-based power sales during the most recent calendar quarter. The CAISO submitted what it believed were compliant First Quarter, Second Quarter, and Third Quarter 2005 EQR fillings, in accordance with Order No. 2001, *et seq.*, on April 4, 2005, July 21, 2005, and October 12, 2005, respectively.

On November 29, 2005, the EQR Technical Compliance group sent an email notice informing the CAISO that it had failed one or more of the Automated EQR Technical Compliance Screens in filings submitted for the first three quarters of 2005 and informed the CAISO that corrections or responses must be submitted within 30 days of the November 29, 2005, notice. A teleconference was held by EQR staff on December 14, 2005, for purposes of discussing the

results of the EQR Technical Compliance Screening Process and resulting reports.

III. Request for Extension of Time

The CAISO seeks an extension of time until February 28, 2006, to submit its corrected 2005 EQR filings for the first, second, and third quarters of 2005. Good cause exists to grant this extension. The CAISO requests the extension due to the difficulties associated with attempting to make such extensive corrections within a short period of time. The CAISO has recently undergone a corporate reorganization, leaving considerably fewer resources available and making it difficult to provide a response in the timeframe requested by the Commission. Additionally, the CAISO's remaining resources are particularly impacted during the month of December due to already scheduled time off associated with the holiday season. It is also during this time that CAISO staff must begin the process of preparing for the Fourth Quarter 2005 EQR filing due in January 2006. The requested extension will allow the CAISO the time needed to digest and apply the direction provided in the December 14, 2005, teleconference. Moreover, the CAISO does not wish to burden the Commission, or to tax its own limited resources, by submitting multiple corrected EQRs.²

The fact that a key CAISO employee involved in the EQR process will not be available during the time when she otherwise would be working on the corrected EQR (to the extent

Due to the short time remaining before the corrected EQRs are due, the CAISO respectfully requests that the Commission rule on this Motion as soon as possible

V. Conclusion

For the reasons provided above, the CAISO requests that the Commission grant its request for an extension of time, and allow it to submit its corrected First, Second, and Third Quarter 2005 EQRs on or before February 28, 2006.
