

California Independent System Operator Corporation Entities that have entered into an Interruptible Service Contract or similar agreement

In accordance with AB 621 (codified as Section 349.5 of the California Public Utilities Code), the California ISO ("CAISO") is required to provide notice to Air Quality Management Districts of the name and address of each entity that may be within each district's boundaries with which the CAISO has entered into an "interruptible service contract or similar arrangement." The only entities at this time that may currently qualify for notification pursuant to AB 621 have a Metered Subsystem Agreement ("MSSA"), a Metered Subsystem Agreement ("MSSAA"), a Utility Distribution Company Operating Agreement ("UDCOA"), a Participating Load Agreement ("PLA"), a Participating Load Pilot Agreement ("PLPA"), or a Proxy Demand Resource Agreement ("PDRA") with the ISO.
