On January 17, 2006, the California Independent System Operator Corporation ("ISO")¹ submitted a compliance filing in the captioned docket ("January 17 Filing") to amend the Metered Subsystem ("MSS") Agreement between the ISO and the City of Vernon, California ("Vernon").
