**Re: California Independent System Operator Corporation
Informational Filing of Effective Date of RA Enhancements**

Dear Secretary Bose:

On March 29, 2021, the California Independent System Operator Corporation (CAISO) proposed four sets of tariff amendments as the first phase of the resource adequacy (RA) enhancements initiative. The CAISO proposed two sets of tariff language with different effective dates, the first set to take effect on June 1, 2021, and the second set to take effect no later than June 15, 2021. By order issued May 28, 2021, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation of the second set of tariff changes.¹

On June 8, 2021, the CAISO submitted a petition for limited tariff waiver, requesting to extend the deadline of the remaining tariff changes to take effect no later than July 31, 2021. The Commission has yet to issue an order on this waiver.

The CAISO implemented the second part of RA enhancements on June 30, 2021. Accordingly, the CAISO is submitting this informational filing to specify an effective date of June 30, 2021 for the second set of tariff revisions accepted by the Commission in this docket.² The CAISO is requesting a waiver of the five-day
