On May 19, 2020, California Independent System Operator Corporation (CAISO) filed a certificate of concurrence corresponding to an Affected Participating Transmission Owner Upgrade Facilities Agreement (UFA) among Southern California Edison Company, Atlas Solar, LLC, and CAISO, which was accepted effective April 14, 2020.¹ Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted,² and the certificate of concurrence is accepted for filing, effective April 14, 2020, as requested.³

This filing was noticed on May 20, 2020, with comments, protests, or motions to intervene due on or before June 9, 2020. No protests or adverse comments were filed.
