GENERAL SESSION

The interim Director Market Monitoring, Dr. Eric Hildebrandt, officially started the meeting shortly after 10:00 a.m., beginning with a quick run-down of the agenda.

The meeting was then turned over to Chairman Wolak whereby he thanked everyone for attending and introduced the two other committee members.

Public Comment

Dr. Wolak asked if any member of the public wished to make a general comment before the committee addressed the items on the agenda. As no party came forward to make public comment, the committee then moved on to the agenda items.

1. Discussion on Scarcity Pricing

Kallie Wells, Market Monitoring Analyst with the Department of Market Monitoring, provided an overview of the Ancillary Service Market, its performance and functionality since the start of the new market design.

Dr. Shucheng Liu, Principal Market Developer, then provided a briefing of the ISO's revised reserve scarcity pricing proposal.

Throughout both presentations, stakeholders and MSC members asked various clarifying questions.

2. Discussion on Convergence Bidding

Chairman Wolak gave a presentation summarizing the direction of the MSC's thinking on the California ISO's proposal on Convergence Bidding, and noted that the MSC would be providing a formal opinion on the ISO's convergence bidding proposal at the October Board meeting. During Chairman Wolak's presentation he pointed out several features of the ISO's proposal on which he was seeking stakeholder comments. This presentation was followed by discussion among MSC members and stakeholders.

This agenda item was a discussion item only and did not require any action be taken by the MSC.

3. <u>Discussion on Competitive Path Assessment Study</u>

The final presentation giving was from Dr. Dan Yang of the Department of Market Monitoring. Dr. Yang's presentation focused on the preliminary results analysis that the Department of Market Monitoring had prepared to assess the competitiveness of paths under actual market conditions using an alternative approach similar to that used by numerous other Independent System Operators.

This agenda item was a discussion item only and did not require any action be taken by the MSC.
