**MOTION FOR AN EXTENSION OF TIME**

The California Independent System Operator Corporation ("ISO"), pursuant to Rule 212 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.212, hereby respectfully moves for an extension of time to revise its billing and make refunds, and for the submission of the subsequent refund report in the above-captioned proceeding. Specifically, the ISO seeks an extension of 30 days to July 19, 2004 to make the refunds and 30 days thereafter to file a refund report.

In support of the Motion, the following is shown:

1. On April 20, 2004, the Commission issued its Order on Arbitrator's Award ("April 20 Order") in the above captioned proceeding. In the April 20 Order, the Commission directed the ISO to revise its billing and make specific refunds, with interest, as appropriate, to the Cities of Anaheim, Azusa, Banning, Colton and Riverside,

California, and the City of Vernon, California (together “the Cities”) within 60 days and, within 30 days thereafter file a refund report with the Commission.

2. The refunds relate to costs incurred during the time period from February 7, 2000 to March 22, 2000 and passed on to the Cities, among others. Upon receipt of the April 20 Order ISO Settlements personnel began the task of working through the data to prepare to revise the appropriate bills and make the directed refunds. This task proved to be lengthy and complex due to the passage of time and the number of reruns etc. since the original trade dates. These factors, along with the pressing requirements elsewhere upon ISO Settlements staff, used most of the original 60 day period directed in the April 20 Order.

3. On June 7, 2004 the ISO communicated with various counsel for the Cities to advise of the slow progress in the task of revising the affected bills. The ISO also advised the Cities of discrepancies that were becoming evident in the records being revised by the ISO. The ISO requested to confer with the Cities to reconcile the discrepancies in order to avoid a variance with the sums directed for refund in the April 20 Order.

4. On June 9, 2004 the ISO forwarded to counsel for the Cities spreadsheets indicating the figures derived from the ISO’s revisions. Since that date the ISO has been advised that the settlements personnel at the various cities are reviewing the ISO’s spreadsheets regarding the discrepancies. The Cities have yet to revert formally to the ISO on these data.

5. The ISO anticipates that agreement will be reached between the ISO and the Cities but expects that this may take several more weeks.

6. The ISO is authorized to state that the Cities do not object to the extension requested herein.

7. The ISO, accordingly, requests an additional 30-day extension of time from June 19, 2003 until July 19, 2004, to complete the revision of the bills and make the refunds and a consequential extension of time, i.e. the additional 30 days from July 19, to file the refund report.

**WHEREFORE**, in view of the foregoing, the ISO respectfully requests that the Commission grant the instant Motion for an Extension of Time.
