2. Please provide feedback on the financial compensation for reactive power.

NRG appreciates that the CAISO is now actively addressing the issue of reactive power compensation for generating resources as the 10<sup>th</sup> anniversary of FERC's order directing the CAISO to address reactive power compensation nears.<sup>1</sup>

Of the two options for providing reactive power capability compensation offered by the CAISO (the "AEP methodology", which involves cost-of-service filings at FERC, or the "safe harbor" approach, which involves establishing a uniform \$/MVAr-year capability payment)<sup>2</sup>, NRG respectfully urges the CAISO to move forward with the second option – establishing a uniform "safe harbor" rate for reactive power capability. and ISO-New England currently use this uniform rate methodology.<sup>3</sup> This uniform rate methodology obviates the burdensome need to develop cost-of-service rates and file those rates with FERC, which reduces the administrative burden, litigation risk and expense for all parties.

NRG's preference for this approach is conditioned on the expectation that generators will be compensated by a just and reasonable rate.
