**COMPLIANCE FILING OF THE
CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION**

The California Independent System Operator Corporation (“CAISO”) respectfully submits this compliance filing in response to the Commission’s August 28, 2019 “Order on Rehearing.”¹ In its Order on Rehearing, the Commission granted the CAISO’s rehearing request, accepting the previously filed informational reports² setting for the CAISO’s proposed resettlement. The Order on Rehearing also directed the CAISO to

apply interest on the earlier resettlement and submit this compliance filing to reflect the CAISO's plans to invoice and distribute interest amounts.³

The CAISO is still in the process of calculating interest and plans to issue settlement statements and invoices by March 31, 2020. The CAISO will submit a supplemental filing in Q1 2020 reflecting interest calculations through March 31, 2020. When the calculations are available in early Q1 2020, the CAISO Client Services will conduct outreach and provide affected scheduling coordinators with their interest calculations.
