# Which facilities are subject to the 30-Day Rule?

Affected facilities are:

- Transmission facilities above 200 kV
  - Facilities included in the Transmission Register
  - Facilities of CAISO Controlled Grid
- Facilities on the "30-Day Rule List"
  - Iisted on T-113 Attachments Q, R, or S



## Are there exceptions to the 30-Day Rule?

Yes. Outages of affected facilities that:

- Are not of a duration greater that 24 hours
- Previously approved outages moved within the same calendar month
- Are approved maintenance activities in E-509
  - Restricted Maintenance Operations



# What about rescheduling 30-Day Rule outages?

- A previously approved outage may be rescheduled by facility owner within the same calendar month
  - Unless there are conflicting outages
  - Must be requested three business days prior to outage
- Maintains "scheduled" "planned" designation
- Outages rescheduled at CAISO request
  - Remain "scheduled" "planned"




# What is the deadline to submit planned Outages?

- Outages subject to 30-Day Rule:
  - 30 days prior to the calendar month when the outage begins
- Outage subject to 3day rule:
  - 11:30 AM, three business days prior to start of outage
    - No Change to current practice




## Current and Continuing "3-Day Rule"

# What if outages can't meet the 30-Day rule?

- The 30-Day Rule does not restrict needed outages
- Forced Outages
- What would have been "Planned" may now be "Forced"
  - Urgent but not immediate "...could wait a week or two..."
- Outages not meeting "planned" timelines are forced"



## Where is the "30-Day Rule List"? Is it updated?

- The appendices of CAISO Operating Procedure T-113 "Scheduled and Forced Outages"
  - Attachment Q Pacific Gas & Electric
  - Attachment R Southern California Edison
  - Attachment S San Diego Gas & Electric
- Reviewed and Updated no less than annually
- Updated in collaboration with facility owners

## When does the 30-Day Rule become effective?

- 30-Day Rule becomes effective at MRTU "Go Live"
- Qualifying outages for second month due at "Go Live"
- May submit outages now using the 30-day rule
  - CAISO encourages outage submittal up to a year in advance
  - Establish practice before due date
