Enclosed for filing please find copies of a tariff sheet for the California Independent System Operator Corporation ("ISO") FERC Electric Tariff, Original Volume I, submitted in compliance with the Commission's June 17, 1999, Order in the above-referenced docket.

On April 30, 1999, the ISO filed Amendment No. 16 to the ISO Tariff in the above-referenced docket. Amendment No. 16 proposed to extend the existing GMC rate through December 31, 2000.

Parties submitted motions to intervene, comments and/or protests to Amendment No. 16, including some that questioned whether Tariff Sheet No. 375 was correct. On June 4, 1999, the ISO filed an Answer to the motions and comments, indicating that in order to eliminate confusion regarding Tariff Sheet No. 375, the ISO would agree to modify it by deleting the following sentence: "The Grid Management Charge will be \$0.7831 as of March 31, 1998."

On June 17, 1999, the Commission issued an order accepting Amendment No. 16 for filing, accepting the proposed modification to Tariff Sheet No. 375 and directing the ISO to submit a compliance filing incorporating the

ISO's proposed modification. <u>California Independent System Operator Corp.</u>, 87 FERC ¶ 61,304 (1999).
