# DATA REQUESTS



### Data and analysis might be used to support

- Monitoring and assessment of EDAM GHG market design: monitor the realized impacts of GHG market design to inform future enhancements.
- Market participants ability to meet existing compliance obligations: ensure market participants have what they need to inform procurement decisions
- **Regulators developing new and emerging programs:** provide regulators with sufficient information so that they can decide what is practical and salient for compliance with state rules.



#### Problem statement vs data request

# Problem Statement

Market participants do not have sufficient information to make efficient procurement decisions under statues that count market transfers over an annual compliance period

The optimization does not take the explicit cost of secondary dispatch into account, and may not balance optimized attribution withy constraints to limit secondary dispatch

# **Data Request**

Residual emissions rate total emissions emissions intensity of MW attributed below the base schedule

Metrics to inform stakeholders of the emissions impact or efficiency of operations



## Example: Double Counting

- Stakeholder comments to date have offered solutions:
  - coordination between the ISO and WREGIS
  - development of a residual emissions rate
- Problem statements that might support the above solutions should consider
  - Providing examples of how double counting might arise
  - How double counting relates to existing or planned GHG market design
  - What the ISO's role should be in a solution
