## Background on PEDRIT SP

- PEDRIT addresses deferred topics from the Rules of Conduct Enhancements initiative
- Rules of Conduct purpose:
  - Fair notice and equal environment
  - redress market manipulation and anti-competitive behavior
  - foster confidence in markets
- Grounding principles: transparency, respect, feedback



## Background on PEDRIT SP

#### **Topic Summary:**

 Rules of Conduct Enhancements (ROCE) was implemented April 1, 2024

PEDRIT	<ul> <li>Define submission requirements and penalty structure for demand response monitoring data</li> <li>Streamline Rules of Conduct investigative process</li> <li>Update penalty tolling process</li> <li>Inaccurate meter data materiality threshold or waiver (in-scope discussion)</li> </ul>
ROCE	<ul> <li>Meter data penalties</li> <li>Eliminate annual penalty distribution filing</li> <li>Clarify eligibility for penalty distribution</li> <li>Clarify application of market adjustment provision in context of WEIM entities</li> </ul>

Draft final proposal posted	July 11, 2024
Joint Governing Body Meeting	September 26, 2024

# **Topics**



The SP proposes defining the penalty structure for demand response (DR) monitoring data

- Current Rule: The ISO requires DR monitoring data submission after a DR event
- Proposed Rule: DR monitoring data must be submitted by T+52B or will be considered late. Late DR monitoring data will be penalized \$1000 per trading day. Data missing past T+214B will be penalized an additional \$3000 per trading day
  - Penalty applied per SCID, not by resource ID
  - Same penalty for one or multiple data files in violation



## Update penalty tolling process

- Current Rule: ISO collects penalty via settlement statement. If penalty is disputed with the ISO and appealed to FERC by dispute deadline (22 business days), the ISO returns penalty collection pending FERC ruling
- Proposed Rule: SC/MP has 30 days after Results of Review to provide the ISO with a FERC docket number outlining their appeal. If no appeal, the ISO includes penalty on settlement statement



# Streamline rules of conduct investigative process: reduce administrative burden

- **Current Rule**: The ISO employs a three-letter process:
  - Notice: 30 days to submit information
  - Findings: 30 days to appeal findings to ISO
  - Penalty description: potential to appeal to FERC
- The ISO notifies MP's pre-designated contact(s) and SC
- **Proposed Rule:** The ISO employs a two-letter process:
  - Notice: 30 days to submit information, make case
  - Findings (including penalty description): potential to appeal to FERC
- Defines SC as investigative point-of-contact to prepare integrating RoC investigations into CIDI



# Inaccurate meter data materiality threshold or waiver (in-scope discussion)

- The ISO seeks stakeholder perspectives on the following comments:
- Idaho:
  - Minimum materiality impact threshold
- City of Corona:
  - Waiver if first offense is self-reported and/or minor
- **DMM**:
  - Maintain strict deadline and financial penalty
