Purpose and Distribution

The California ISO sends Electrical Emergency Notices when adverse grid or market conditions require activation of the California ISO Electrical Emergency Plan. Notices are targeted to control centers and communications departments of Participating Transmission Owners, Utility Distribution Companies, Metered Subsystems, Market Participants as well as state, federal, regulatory and oversight agencies. Not all Electrical Emergency Notices are necessarily sent to all recipients but rather to the stakeholders for each notice identified by the CAISO. Subsequent re-transmissions of these notices by media, public safety agencies and others extend the audience to a much wider range of recipients than those specified above.


Electrical Emergency Notices may be issued on a CAISO Grid or Regional (Northern or Southern California) basis. In addition to the standardized text in the following pages, CAISO Operators can elect to provide additional details and descriptions specific to the event.

Advisories, NOT Dispatch Instructions

Electrical Emergency Notices do not serve nor should they be mistaken for dispatch instructions or orders issued by the California ISO. They are advisories only and dispatch instructions relative to electrical emergencies will be issued through established modes.

Disclaimer

Electrical Emergency notices are based on current conditions of the transmission grid system. While a CAISO Electrical Emergency Notice reflects the most current information available to the CAISO at the time of issuance, transmission grid system conditions are subject to sudden and rapid change without warning and the accuracy of any notice cannot be assured.
