

In response to comments submitted by CES, after internal discussion and research, the ISO has determined that rather than adjusting the calculation for Undelivered Spinning Reserve No Pay as part of the BPM change management process, the more appropriate solution is to address the variance in the RTM application which is incorrectly creating the small AS IIE MWh quantities. As additional support to this approach, the Undelivered No Pay has been calculated since 2000 and the ISO has at no time implemented any AS IIE MWh threshold. Therefore, a precedent has been set in this regard. This issue represents a new variance in the queue and as such has not been prioritized for resolution. The ISO will provide a status update when more information is available.
