MOTION TO INTERVENE OF CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

Pursuant to Rule 214 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.214, and the Commission's April 5, 1999, Notice, the California Independent System Operator Corporation ("ISO") hereby moves to intervene in the above-identified proceeding.

MOTION TO INTERVENE

The ISO is a non-profit public benefit corporation organized under the laws of the State of California and responsible for the reliable operation of a grid comprising the transmission systems of Pacific Gas and Electric Company ("PG&E"), San Diego Gas and Electric Company, and Southern California Edison Company (the "ISO Controlled Grid"). This proceeding concerns a Transmission Owner Tariff ("TO Tariff") filed by PG&E that includes wholesale and retail rates for the transmission service that the ISO provides on the ISO Controlled Grid. Under the ISO Tariff, the ISO is responsible for the settlement of certain of these charges. The ISO therefore has a unique interest in any FERC proceedings that concern rates for service on the ISO Controlled Grid.

In addition, PG&E's filing implements certain matters included in a settlement filed in a previous PG&E TO Tariff proceeding, Docket Nos. ER97-2358, *et al.* The ISO has been granted intervenor status in those proceedings. The ISO should therefore be permitted to intervene in this proceeding.
