

#### AUP - OMS & BSAP, SIBR, BAAOP

- MAPStage is supported during business hours, M-F
- Sometimes participants are testing API's on their side which floods CAISO systems, thus preventing other users from accessing
- Logs can fill up, causing disk space issues
- Will use same AUP criteria as CMRI

  - AUP will be enforced for Retrieves if the same transaction is seen within 5 seconds, with these permutations:
    - Certificate/User
    - Retrieve Service Invoked
    - And if derived in XML:
      - MRID/Resource ID
      - Market Org Outage ID
      - Begin Date
      - End Date

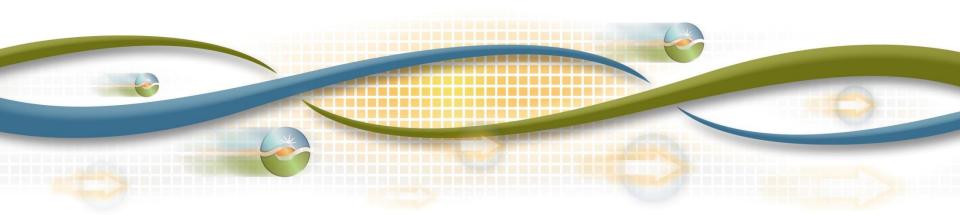

# Disabling TLS 1.0

*MAP-Stage Readiness*August 2017



#### Disabling TLS 1.0

Following best security practice, the ISO is preparing to disable TLS versions 1.0 and 1.1 in its portal environments.

Participants need to ensure that their browser and API clients support TLS 1.2.

The change in MAP-Stage (<a href="https://portalmap.caiso.com">https://portalmap.caiso.com</a>) is currently scheduled for the week of 8/21/17 and will be preceded by a Market Notice.


This schedule allows time to enable TLS 1.2 in OMS APIs.

Participants should test ADS, OMS, and CMRI UIs and APIs.

Even before the change in MAP-Stage, participants can test by forcing a TLS 1.2 connection, since TLS will always negotiate the highest mutually allowed version.

## **API Testing**

Testing APIs is implementation specific.

#### OpenSSL and cURL are common API testing tools.
