



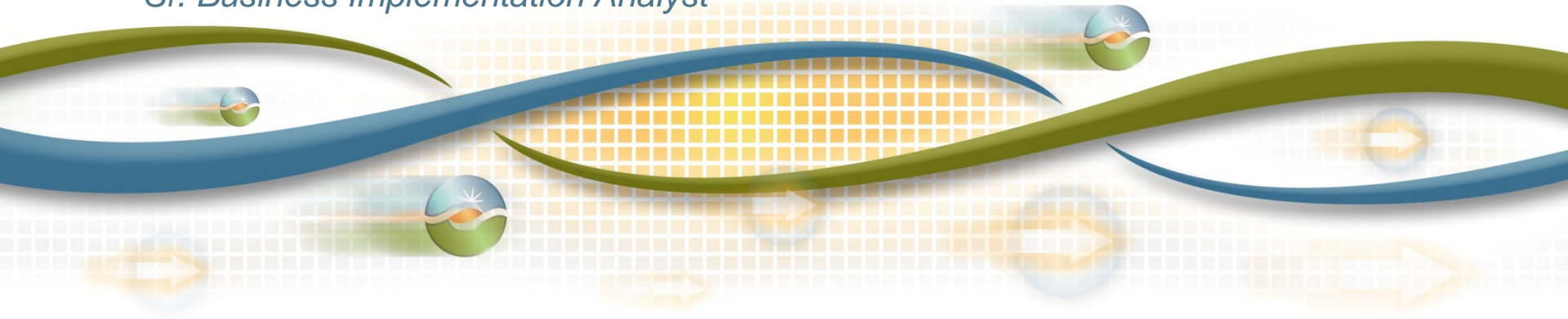

Known issues and workarounds

- Extension of advisory period
- Use-plan limitations
- DCCP miscalculation
- Transition issue - RAAIM charges for planned outages post November, 1st 2016
- DST issue with RAAIM calculation

Known issues and workarounds

- Settlement Configuration Updates – PRR 959 and 960
 - RA Availability not including multiple self schedules
 - RA Availability capped to zero when use limit reached
 - Flex RA exemption calculation not including full Pmin
 - Include CIRA outputs on daily bill determinant xml file

43448	<p>CIDI-00181232: ability to cancel an ED once it has been declined</p> <ul style="list-style-type: none">- We can put a warning "This action will result in supplemental revenue for the next 30 days. Do you wish to continue?" <p>CIDI-00181230: After search, the monthly/intra-monthly/annually and start and end dates should be available so that users shouldn't have to reload the screen to re-query the results.</p> <p>CIDI-00181223: CPM Type should be more descriptive</p>
41007	CIDI-00181431 -Allow users to load offers from Monthly and copy into Intra-monthly offers.
41008	Make the CSP Offers window variable size. The search for available resources window is able to be variable size but the CSP offers window is not. It would be easier if the window can be made longer to let users see the entire list of offers.
