# Informational Filing of Effective Date of Rules of Conduct Tariff Amendment

#### Docket No. ER24-872-000

Dear Secretary Reese:

On January 12, 2024, the California Independent System Operator Corporation (CAISO) proposed tariff amendments to update parts of Section 37 of the CAISOs tariff, known as the rules of conduct. By letter order issued March 22, 2024, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within 30 days of implementation.<sup>1</sup>

The CAISO implemented the tariff changes for the rules of conduct initiative on April 1, 2024. Accordingly, the CAISO is submitting this informational filing to specify an effective date of April 1, 2024 for the tariff revisions accepted by the Commission in this docket.<sup>2</sup>
