Dear Ms. Mannheim:

On November 18, 2016, California Independent System Operator Corporation (CAISO) submitted for filing numerous ministerial revisions to its Transmission Tariff to reconcile overlapping submittals and thereby accurately reflect the cumulative result of revisions to the same tariff sections submitted for filing in different proceedings. CAISO does not propose any new revisions or changes to any previously approved tariff provisions, and requests acceptance of the reconciled tariff records effective as of the latest effective date previously approved for the relevant tariff record. Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted,¹ and the revised tariff records are accepted for filing, effective as of the latest effective date previously approved for the relevant tariff record, as requested.²

The filing was noticed on November 19, 2015, with comments, protests, or interventions due on or before December 9, 2015. No protests or adverse comments were

filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification or any rule, regulation or practice affecting such rate or service contained in your filed documents; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or any which may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against CAISO.

This action is taken pursuant to the authority delegated to the Director, Division of Electric Power Regulation - West under 18 C.F.R. § 375.307. This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
