Informational Filing of Effective Date of Load, Exports, and Wheeling Tariff Amendment

Docket No. ER21-1790-___

Dear Secretary Bose:

On April 28, 2021, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to implement market enhancements for summer 2021 regarding load, export, and wheeling priorities. The CAISO proposed three sets of tariff language with three different effective dates: the first set to take effect on June 28. 2021, the second set originally filed with an open-ended effective date and to take effect no later than July 15, 2021, and the third set to take effect on June 1, 2022. By order issued June 25, 2021, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation of the second set of tariff changes.¹ The Commission also directed the CAISO to submit a further compliance filing incorporating the penalty pricing parameter values associated with the revised scheduling run priories into its tariff. On July 26, the CAISO submitted the compliance filing. The CAISO subsequently submitted a supplemental compliance filing on August 4, which revised the proposed effective date of the July 26 compliance filing tariff records and made one revision to section 31.4.1 clarifying its authority to make temporary changes to the scheduling parameter values. The Commission has yet to issue an order on these compliance filings.

Cal. Indep. Sys. Operator Corp., 175 FERC ¶ 61,245 (2021). The Commission directed the CAISO to notify the Commission of the actual effective date of the Tariff revisions within five business days of their implementation, in an eTariff submittal using Type of Filing Code 150 – Report.

On July 9, 2021, the CAISO submitted a petition for limited tariff waiver, requesting to extend the deadline of the second set of tariff changes to take effect no later than July 30, 2021. On July 29, 2021, the Commission issued an order granting the waiver request. On July 28, 2021, the CAISO submitted a second petition for limited tariff waiver, requesting to extend the deadline of the second set of tariff changes to take effect no later than August 31, 2021. The Commission has yet to an issue an order on this second waiver request.

The CAISO implemented the second set of tariff changes for Load, Exports and Wheeling Priorities on August 4, 2021. Accordingly, the CAISO is submitting this informational filing to specify an effective date of August 4, 2021 for the second set of tariff revisions accepted by the Commission in this docket, as well as for the supplementary compliance filing tariff records.² It should be noted that for several tariff records, the supplementary compliance filing records will immediately supersede the versions submitted on April 28, as shown in Attachment A.

The CAISO has served copies of this filing on all the parties to the service list for this proceeding. In addition, the CAISO is posting this filing on the CAISO website.
