Dear Secretary Bose:

The California Independent System Operator Corporation ("CAISO") hereby submits for filing a Certificate of Concurrence with respect to the unexecuted Large Generator Interconnection Agreement ("LGIA") among Regents of the University of California ("UC Regents"), Pacific Gas and Electric Company ("PG&E"), and the CAISO ("UC Regents LGIA").1

I. **Overview and Designated Filer**

The UC Regents LGIA was filed with the Commission on May 26, 2017, as an unexecuted conforming pro forma LGIA by PG&E as the Participating Transmission Owner and a party to the LGIA, as a PG&E service agreement.² The filling concerned a dispute by the UC Regents regarding the pro forma language in Article 18 to the UC Regents LGIA.

The CAISO filed intervenor comments on June 16, 2017 in support of PG&E's argument that the UC Regent's proposed changes in the indemnity language in Article 18 of the LGIA are not superior to the pro forma language and

The UC Regents LGIA is designated as Service Agreement No. 344 under PG&E's Transmission Owner Tariff, FERC Electric Tariff Volume No. 5.

should be rejected. The Commission accepted the LGIA for filing via letter order on July 20, 2017.³

Rather than filing a duplicate version of the UC Regents LGIA under the CAISO tariff, the CAISO is submitting a concurrence tariff record that is attached to the instant filing. The concurrence tariff record is designated with the same service agreement number as PG&E's service agreement number – Service Agreement No. 344.

PG&E serves as the "designated filer" as to the UC Regents LGIA pursuant to the Joint Tariff Filing procedures outlined in Order No. 714.4

II. Proposed Effective Date and General Request for Waivers

The CAISO respectfully requests any waivers of the Commission's filing regulations necessary to establish an effective date of July 27, 2017 for its Certificates of Concurrence, consistent with the July 27, 2017 effective date that PG&E requested in its filing. To the extent that the enclosed materials and information do not meet the detailed filing requirements of the Commission's regulations, the CAISO respectfully requests that the Commission grant any necessary waivers.
