## Informational Filing of Effective Date of Revised Transmission Control Agreement

## Docket No. ER20-1137-000

Dear Secretary Bose:

On March 2, 2020, the California Independent System Operator Corporation (CAISO) filed a revised Transmission Control Agreement (TCA) to add DesertLink, LLC (DesertLink) as a new participating transmission owner (PTO) and to make other changes to the TCA. The CAISO requested an effective date of April 30, 2020 for all of the TCA revisions but also requested that, if the DesertLink facilities were energized after April 30, the Commission direct the CAISO to submit a further filing to revise only the effective date of the TCA revisions necessary to add DesertLink as a new PTO.<sup>1</sup>

By letter order issued April 21, 2020, the Commission accepted the TCA revisions effective April 30, 2020 as requested by the CAISO, noting that if the CAISO requires a later effective date for the TCA revisions necessary to add DesertLink as a new PTO in the event that the DesertLink facilities are energized after April 30, the CAISO must make an informational filing to specify that effective date.

The DesertLink facilities were energized on August 12, 2020. Accordingly, the CAISO is submitting this informational filing to specify an effective date of

August 12 for the TCA revisions accepted by the Commission that are necessary to add DesertLink as a new PTO.<sup>2</sup>
