The California Independent System Operator Corporation ("CAISO") hereby submits for filing a Certificate of Concurrence with respect to the non-conforming Large Generator Interconnection Agreement ("LGIA") among Arica Solar, LLC ("Interconnection Customer"), Southern California Edison Company ("SCE"), and the CAISO ("Sol Catcher BESS LGIA").1

# Overview and Designated Filer

On August 4, 2021, SCE submitted the Sol Catcher BESS LGIA in Docket No. ER21-2607, with a requested effective date of August 5, 2021. In that filing, SCE explained that the Sol Catcher BESS LGIA contains non-conforming language related to shared Interconnection Reliability Network Upgrades. In particular, the LGIA provides that the Interconnection Customer is jointly and severally liable for the cost of the shared Interconnection Reliability Network Upgrades, as described in Section 5 (d)(ii) of Appendix A to the LGIA.

Additionally, SCE requested, pursuant to Section 35.11 (18 C.F.R. § 35.11) of the Commission's regulations, a waiver of the 60-day prior notice requirements specified in Section 35.3 (18 C.F.R. § 35.3) and requested that the Commission assign an effective date of August 5, 2021 to the LGIA, which is the day after SCE's filing of the Sol Catcher BESS LGIA.

The CAISO submits this filing pursuant to Sections 35.1 and 131.52 of the Commission's regulations, 18 C.F.R. §§ 35.1, 131.52.

Rather than filing a duplicate version of the Sol Catcher BESS LGIA under the CAISO tariff, the CAISO is submitting a concurrence tariff record. The concurrence tariff record is designated under the CASO tariff as Service Agreement No. 6872.

SCE serves as the "designated filer" to the Sol Catcher BESS LGIA pursuant to the Joint Tariff Filing procedures outlined in Order No. 714.<sup>2</sup> As the Participating Transmission Owner and a party to the LGIA, SCE filed the service agreement under SCE's FERC Electric Tariff, Original Volume No. 6 and designated it as Service Agreement No. 272.

# II. Proposed Effective Date and General Request for Waivers

The CAISO respectfully requests any waivers of the Commission's filing regulations necessary to establish an effective date of August 5, 2021 for its Certificate of Concurrence for the Sol Catcher BESS LGIA, consistent with the August 5, 2021 effective date that SCE requested in its August 4, 2021 filing. To the extent that the enclosed materials and information do not meet the detailed filing requirements of the Commission's regulations, the CAISO respectfully requests that the Commission grant any necessary waivers.
