ANSWER OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION TO COMMENTS

The California Independent System Operator Corporation (CAISO) files this brief answer to the comments submitted by The City of Santa Clara, doing business as Silicon Valley Power (SVP), in response to the tariff amendment the CAISO filed in this proceeding on July 28, 2017 (July 28 Amendment). The July 28 Amendment proposed to eliminate the requirement in the CAISO's tariff to develop a conceptual statewide plan as part of its annual transmission planning process.

SVP notes that the July 28 Amendment inadvertently retained a reference to a tariff section the CAISO proposes to remove from the tariff. In that regard, the July 28 Amendment proposes to delete tariff section 24.4.4 in its entirety. However, tariff section 24.13, which the CAISO inadvertently did not modify in the July 28 Amendment, contains reference to section 24.4.4. This was the result of administrative oversight. The CAISO agrees with SVP that the reference to section 24.4.4 should be removed from section 24.13b because the CAISO is removing section 24.4.4 from the tariff in its entirety.² The CAISO proposes to

remove the reference to 24.4.4 in section 24.13 on compliance with the Commission's order in this proceeding.

For the foregoing reasons, the CAISO requests that the Commission accept the tariff revisions contained in the July 28 Amendment as submitted, subject to modifying section 24.13 on compliance, as discussed herein.
