On July 8, 2020, California Independent System Operator Corporation (CAISO) filed a notice of cancellation of the Pseudo Participating Generator Agreement with CCFC Sutter Energy, LLC.¹ Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted,² and the notice of cancellation is accepted for filing, effective July 1, 2020, as requested.

This filing was noticed on July 8, 2020, with comments, protests, or motions to intervene due on or before July 29, 2020. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.
