1. Introduction

1.1 Purpose

The purpose of this document is to capture and record a description of what the Users and Business Stakeholders of the **Commitment Cost Enhancements Phase 3** project wish to obtain by providing high-level business requirements. This document establishes the basis for the agreement between the initiators and implementers of the project. The information in this document serves as input to determining the scope of projects and to all Business Process Modeling and System Requirements Specifications efforts.

This initiative is a continuation of the Commitment Cost Enhancements Phase 2 initiative and will entail developing a methodology for calculating use-limited resource opportunity costs and creating opportunity cost adders for bidding into the ISO market using the proxy cost option. After implementing these changes, the ISO will still keep registered cost option for a period of time (configurable) until the ISO evaluates the effectiveness of the newly-implemented opportunity cost model. The ISO will decide when to retire the registered cost option upon this evaluation, or decide to keep it indefinitely.

2. Intellectual Property Ownership

Intellectual property covers a broad array of information and materials, including written works, computer programs, software, business manuals, processes, symbols, logos, and other work products. Determining ownership of intellectual property is very important in preserving rights of the California ISO and helps to avoid intellectual property infringement issues. In considering the business requirements or service requirements to be performed, the business owner of the project must determine intellectual property Ownership.

2.1 Guidelines


Intellectual property ownership must be considered by all applicable stakeholders before the services are performed. The level of analysis is two-fold. One, the business owner must determine if the intellectual property necessary to perform the services is owned by the California ISO or whether it must be obtained from a third party. Once it has been determined that the California ISO has secured the proper intellectual property rights to perform the services (i.e., the intellectual property is owned by the California ISO or we have licensed it from a third party), then the second step in the analysis is to consider whether new intellectual property will be created as a result of the business requirements or service requirements to be performed and how that intellectual property will be owned and protected by the California ISO. In order to assist the business owner in the analysis previously described, refer to the California Intellectual Property Policy available at http://www.caiso.com/rules/Pages/LegalPoliciesNotices/Default.aspx, which provides a brief tutorial on what Intellectual Property is and how the California ISO can go about protecting its intellectual property. Use limited resource is defined as the resource with limited starts, run-hours, or energy output and the market will use limited opportunity cost to adjust commitment cost bid caps and default energy bids (DEBs).

For a resource to be considered use-limited and be eligible for an opportunity cost, it must first register as a uselimited resource.

- 1) **Supporting documentation:** For each resource applying for use-limited status, the market participant will submit to the ISO copies of original documentation stating the resources' limitations or restrictions on start, run-hours, energy output, or other limitations, that cannot be optimized within the ISO optimization horizon, as imposed by regulatory agencies, legislation, or providing evidence of design limitations and in the case of translated limitations, the methodology used.
- 2) **Documentation review:** ISO will verify and validate that 1) the resource meets the definition of use-limited and is eligible for an opportunity cost, and 2) the limitations identified in the use plan are supported by the documentation provided or that the methodology used to translate limitations into starts, run hours, or energy output is reasonable and results in identified limitations.
- 3) Maintaining opportunity costs and use-limited status: All resources seeking use limited status will need to register in an initial process. In subsequent years following the first registration process, if nothing has changed from the supporting documentation previously submitted and reviewed by the ISO, scheduling coordinators can submit an affidavit in lieu of re-submitting all supporting documentation already on file and reviewed by the ISO. SC needs to submit the ULPDT every year for the following years (due date is in October), even if there's no change from previous year.
- 4) Use-limited registration of new resources: Scheduling coordinators seeking use-limited status for existing or new resources for the first time must complete the registration process and provide all required documentation and allow sufficient time for the ISO to review documentation and complete the process to calculate an opportunity cost prior to the first applicability date of the limitation.

3.1.2 Evaluating submitted limitations/Opportunity Cost Calculation

The ISO will evaluate each submission on a case-by-case basis to determine whether the submission meets the first two criteria (refer to section 3.1.3 below) of the use limited definition to be eligible for inclusion in opportunity cost calculation model. Opportunity cost adders will be added to the bid cap for commitment costs (start-up costs, transition costs, and/or minimum load costs), after applying the current 125% bid cap, or added to the resource's Default Energy Bid (DEB) (cost-based only).

- 1) **Modeled Limitation:** For each resource, the ISO will use this method to model opportunity cost utilizing the unit's commitment model over future time period (e.g. annual, month) based on projected resource-specific LMPs. Inputs for the model include:
 - a. Use plan limitations
 - b. Unit characteristics
 - c. Commitment cost and Variable Energy Cost (VEC) estimates
 - d. Historical implied heat rate
 - e. Natural gas future prices
 - f. Greenhouse gas prices
 - g. Gas transportation costs (including Cap-and Trade Credit)
 - h. Retail rate for electric auxiliary energy (used in calculations of future EPI)
 - i. Future power price conversion factor
 - j. Net benefits test result

The output of this calculation will be separate resource specific opportunity costs adders for start-up cost, minimum load cost, transition cost, and variable energy cost, as appropriate. They can be reflected in commitment cost bid caps or resource's DEB (cost-based only).

2) Negotiated Limitation: Limitations that the ISO determines cannot be modeled will be eligible to request a negotiated opportunity cost. The scheduling coordinator will provide the opportunity cost(s) and documentation of the modeling methodology for calculating the opportunity cost(s) and proposed frequency of updates for the calendar year. The resource will then use negotiated opportunity cost adders as approved by the ISO based on the submitted methodology. Example of resources expected to use negotiated opportunity cost are: resources with environmental permits (*e.g.*, Delta Dispatch), as well as hydro-electric generating resources.

3.1.3 Use-limited definition

In response to FERC rejection of the revised definition of use-limited as proposed under Commitment Cost Enhancements Phase 2 (CCE2), the ISO added clarity to the definition of use-limited resource. The ISO is narrowing the definition of "use-limited" to just include resources that have an opportunity cost to starts, run-hours, or energy output due to limitations on them that come from external regulatory bodies, legislation, court or due to design or programmatic (demand response) restrictions that cannot be optimized per their limitations because of the ISO's commitment horizon; and that have an opportunity cost for its use. This change now excludes resources that merely can't bid in all hours because they might not be available such as VERs.

The ISO is also adding clarity on the revised definition as follows:

- 1) Will clearly identify the limitations as limits on starts, run-hours, and/or energy output that originate from restrictions imposed by external regulatory bodies, legislation, or courts, or due to the design of the resource where programmatic restrictions under demand response programs apply.
- Will include a non-exhaustive list of specific examples which, to the ISO's understanding, captures the majority of restrictions.
- 3) Will clarify that these cannot be contractual limitations, economic decision based, or due to fuel intermittency. However, the ISO is providing a three year limited exception for long-term contractual limitations on starts, run-hours, or output that were individually reviewed and approved through a comprehensive regulatory process as a new build that evaluated cost implications on ratepayers, after January 1, 2021 they will no longer qualify.
- 4) Will clarify that a use-limitation will be considered under the definition only if the applicability of the limitation is longer than the resource's appropriate commitment process in the ISO market.
- 5) Will clarify that there must be an opportunity cost associated with the registered use limitations.

In accordance with the new definition, the ISO will no longer support a default use limit definition once the opportunity cost adders are effective. At that time, the ISO will eliminate default use-limited designation including any technology specific consideration of resources during the use-limited registration process.

After implementing opportunity cost model, the ISO will still keep registered cost option for a period of time (configurable) until the ISO evaluates the effectiveness of the newly-implemented opportunity cost model. The ISO will decide when to retire the registered cost option upon this evaluation, or keep it indefinitely.

3.1.4 Nature of Work attribute for Outage Cards

When use-limited resource adequacy and flexible resource adequacy resources reach their limitations, scheduling coordinators must submit an outage card indicating the resource has reached the limitation, and is no longer available for the remainder of the limitation horizon. Four "Use-Limited Reached" "nature of work" attributes for generation Outage card have been created by RSI and were implemented for RA resources under that project: Annual, Monthly, Other and Short-term.

RSI provided substitution and RAAIM exemption for use-limited resources that have reached the limitation and submitted a "Use-Limited Reached" outage card during their use-limited horizon for all four categories.

- 1) Makes changes to "Use-Limited Reached" regarding RAAIM Treatment. Retire Annual/monthly/other.
 - RA resources will be exempt from RAAIM for the remainder of the month if submitting any of the four "Use-Limited Reached" outage cards
 - Annual and Other Use-Limited Reached nature of works will have a substitution requirement beginning the first day of the following month and will be exposed to RAAIM.
 - Monthly and Short-term Use-limited Reached nature of works will continue to be exempt from the substitution requirement and therefore exempt from RAAIM.

3.1.5 Master File resource characteristics

ISO will clarify that the responsibility for registering accurate design capability values, where programmatic limitations for demand response resources are considered design limitations, belongs to the Generator Owner.

The ISO will support a subset of resource characteristics as market-based values Market Characteristics in addition to the existing resource characteristics (Design-Capability Characteristics) representing the extreme design values. So there are two sets of Master File values for the subset of characteristics that the market characteristics were deemed appropriate.

- a. Keep all the **existing** resource characteristics Design-Capability Characteristics
- b. Validate that Master File Design-Capability Characteristics support RA obligation.
- c. Minimum requirements for these design-capability characteristics will include:
 - Maximum Daily Starts (MDS) will validate that the design-capability MDS registered values be, at a minimum, 'Q' (configurable, currently defaulted to 2) starts per day except when the designcapability value for MDS is (less than 'Q') starts per day or under a limited exception for resources nearing end of their life cycle.
 - Maximum Daily MSG Transitions (MDMT) will validate that the design-capability MDMT registered values be, at a minimum, 'R' (configurable, currently defaulted to 2) transitions per day except when the design-capability value for MDMT is (less than 'R') transitions per day or under a limited exception for resources nearing end of their life cycle.
- d. Ramp Rates (RR). The design-capability RR should support the RA obligation for that resource. The ISO would monitor the submitted Resource Data Template (RDT) design-capability RR and contact Scheduling Coordinator (SC) for revisions if applicable, where the RR value would not support its RA showing. Add an additional field for a subset of resource characteristics – Market Characteristics
- e. These will be used in the ISO market for normal operations to reflect a balance between technical capabilities and economic trade-offs. These values may be different than the first design-capability set and will be referred to as "market-based" characteristics:
 - 1. **Maximum Daily Starts (MDS)** may warrant being more restrictive than the design-capability values. The ISO will validate that the market-based MDS values be greater than the minimum of 'Q' starts and less than the design-capability MDS unless an exception was provided to the design-capability MDS for less than 'Q' then both values may be less than 'Q'.
 - 2. **Maximum Daily MSG Transitions (MDMT)** may warrant being more restrictive than the design capability of the resources. The ISO will validate that the market-based MDMT values be greater than the minimum of 'R' transitions and less than the design-capability MDMT unless an exception was provided to the design-capability MDMT for less than 'R' then both values may be less than 'R'.
 - 3. **Ramp Rates (RR)**. The ISO proposes to remove the capability to specify operational RR in daily energy bids, and proposes to allow resources to have a market-based RR to reflect the preferred operational RR of the resource under normal system conditions, which must at least support the resource's RA showing value. Also, ISO proposes to remove the capability to specify operating reserve and regulation RRs in daily bids, and proposes to allow resources to have a market-based RRs for operating reserve and regulation.

f. Changes to Master File Market Characteristics that would affect RA obligation.

7. Appendix-2: Technical Appendix

7.1 Introduction

This technical appendix documents the proposed design and methodology for determining opportunity cost (OC) adders for use-limited resources. The ISO is proposing to include OC adders to the commitment cost bid caps and/or the resource's Default Energy Bid (DEB) to enable a more optimal and efficient use of these resources given the limitations that are not considered by the current market optimization.

Commitment Cost Enhancements Phase 3¹ initiative developed a revised definition of use-limited to align uselimited status with resources needing an opportunity cost in commitment costs and DEBs to be optimally committed due to restrictions which extend beyond the ISO's market optimization.

The ISO issued a draft final proposal on February 17, 2016, which was approved by the Board of Governors at the March 25th Board of Governor's Meeting. This technical appendix is intended to provide transparency to the proposed methodology and calculation of opportunity costs. These formulas were initially provided in the straw and revised straw proposals, but were removed from the draft final as the ISO committed to providing a technical appendix with more detail.

The technical appendix is organized as follows:

- Section 7.2 provides a high level description of what constitutes an opportunity cost, the proposed methodology, and how it will facilitate a more optimal and efficient use of use-limited resources.
- Section 7.3 describes the model inputs and formulation of inputs.
- Section 7.4 provides the formulation of the resource-specific opportunity cost model.
- Section 7.5 provides examples of how the opportunity cost model will determine opportunity costs for sample resources with various combinations of limitations.
- Section 7.6 provides the various permutations on cost estimate formulas for non-gas fired resources with and without greenhouse gas compliance obligations.
- Section 7.7 provides more detailed information on the data sources necessary for the cost estimate calculations.

7.2 Overview of Opportunity Cost

Use-limited resources have start and run limitations due to environmental or other operational restrictions. These restrictions extend beyond a one-day period and therefore cannot be explicitly recognized in the ISO market commitment decision. For example, an environmental restriction may limit a resource's run time over a single month to only 200 hours. However, the ISO's day-ahead market only considers a single day.

The ISO's optimization does not currently take into account that dispatching a resource in the current day may restrict its ability to run later in the month. When a resource runs in lower-priced hours, it incurs an opportunity cost to the extent it is not available in higher priced hours. Including opportunity costs in commitment costs and DEBs, however, can allow the ISO market to optimally commit these resources by considering the limitations that extend beyond a single day, such as over a month or a year.

Commitment Cost Enhancements Phase 3 proposed a methodology to determine resource-specific opportunity costs for limitations of use-limited resources. If the resource and limitations lend itself to be modeled, the opportunity cost will be determined by modelling the market commitment of these resources based on projected locational marginal prices. The ISO will update these opportunity costs monthly throughout the year to reflect each resource's actual commitment by the market. Sections 7.3 through 7.5 below go into more detail of the opportunity cost model. Resources and limitations that cannot be modeled utilizing the method below can receive a negotiated opportunity cost.

The end result enables use-limited resources to reflect the opportunity costs in daily commitment costs bids and DEBs. This increases market efficiency by increasing consistent participation of use-limited resources and allowing the market to determine the most optimal commitment and use of use-limited resources.

7.3 Opportunity Cost Model Inputs

This section discusses resource characteristics and market inputs used in the optimization model.

7.3.1 Resource Characteristics and Constraints

The ISO will use the following Master File characteristics in the resource-specific opportunity cost model. The most recent values will be used in the model. The labels provided in parentheses will be the notation of that variable used throughout the technical appendix.

- (1. Minimum operating level (Pmin_{k(w)})
- (2. Maximum operating level (Pmax_{k(w)})
- (3. Minimum Up Time (MUT_{k(w)})
- (4. Minimum Down Time ($MDT_{k(w)}$)
- (5. Maximum Daily Starts (MDS_{k(w)})

Where:

- k denotes MSG configuration (or non-MSG resource)
- w denotes MSG plant (or non-MSG resource)

The ISO will rely on limitations identified on the use-limit plan data template (ULPDT) to determine the resource's use-limitation(s). The limitation(s) will be in terms of maximum starts (implied for MSG resources, including MSG transitions) (MaxSTRT_{k(w)}), run-hours (MaxHRS_{k(w)}), and/or output (MaxMWH_{k(w)}). When the opportunity cost is updated as a resource is part way through the limitation horizon, the limitation used in the model will be based on the remaining available limitation.

7.3.2 Estimated Costs

The model will use estimated variable energy, minimum load, start-up, and transition costs of the resource. The commitment cost estimates will be based on the proxy cost formulas as described in the Market Instruments Business Practice Manual² with adjustments necessary to forecast the costs over the modeled time horizon. The variable energy cost calculation will be a megawatt weighted cost based on the Default Energy Bid (DEB) formulation, or equivalent, as described in Attachment D of the Market Instruments BPM.

The following formulas are for gas-fired resources. The permutations of the formulas for non-gas fired resources can be found in Section 7.6.

Variable Energy Cost

The model will use an estimated Variable Energy Cost (VEC_{*m,k*}) for each month in the model for the entire output range of the resource. The monthly VEC will be based on the resource-specific megawatt weighted average heat rate, monthly forward natural gas prices, and the most recent natural gas transportation costs, greenhouse gas costs, and O&M Adder.

Note: For MSG resources, the monthly VEC will be on configuration level 'k'.

The monthly VEC (\$/MWh) will be determined as follows:

(1) $VEC_{m,k} = \sum_{g} (SegMW_{g,k}^* (HR_{g,k} / 1,000 * (NatGasF_{m,l} + GasT_{m-1,l} + GHGas_{m-1} * EmRate_k) + O&M_k)) / \sum_{g} (SegMW_{g,k})$

7.3.3 Estimated LMPs

The opportunity cost model will determine the optimal commitment of the resource using the above described resource characteristics, constraints, and estimated costs. The model will also use estimated fifteen minute locational marginal prices (LMPs). The ISO will estimate real-time prices by:

- (A) **Equation (4a):** Calculating a 15-minute implied marginal heat rate at each uselimited resource 'k' $(ImpHR_{k,f-1y})$ based on fifteen minute real-time energy prices $(LMP_{k,f-1y})$, using $LMP_{i,f-1y}$ at pnode 'i') from the same time period the previous year (f-1y).
- (B) **Equation (4b):** Calculating an hourly implied marginal heat rate at each uselimited resource 'k' $(ImpHR_{k,h-1y})$ for the same time period the previous year (h-1y) as the simple average of the resource specific four 15-minute (f-1y) implied heat rate $(ImpHR_{k,f-1y})$ corresponding to (h-1y) hour.
- (C) **Equation (5):** Calculating a power price conversion factor $(PPConv_{hub,m})$ based on the ratio of an implied heat rate of future power prices $(ImpHRF_{hub,m,tou})$ and an implied heat rate of historical power prices $(ImpHRH_{hub,m-12,tou})$.
- (D) Equation (6): Scaling the implied heat rate from (B) by the power price conversion factor from (C).
- (E) **Equation (6):** Estimating the hourly real-time energy prices $(LMP_{k,h})$ by applying the natural gas future prices, gas transportation costs, and greenhouse gas costs to the scaled implied heat rates from (D).

Each step is described in more detail below.

Each interval's and location's LMP is assumed to reflect the heat rate of a marginal unit, and that heat rate can be inferred from the prices of gas and emissions allowances at that time and place. This procedure will allow the implied heat rate to inherently capture real-time price volatility, which will then be used to forecast future prices.

7.4 Opportunity Cost Model Formulation

The opportunity cost methodology estimates the foregone profits of the last start, run-hour, and/or MWh assuming the resource is committed when most valued. The objective function of the opportunity cost model will be to maximize total profits given the estimated LMPs, estimated costs, resource characteristics, and constraints. Below is the mathematical formulation of the profit maximizing objective function based on hourly real-time intervals.

<u>Note</u>: The last three constraints represent the limitations for which an opportunity cost needs to be calculated. A resource may have one, two, or all three limitation types. A resource may have more than one limitation type with different applicability horizons (annual and monthly start limitations).

The solution to the objective function is the estimated profits of the resource over the modeled horizon. This estimated profits will then be used to determine the opportunity cost for each limitation type, starts (implied, including MSG transitions), run-hours, and energy output by reducing the limitation by $Y_{k(w),v}$ and re-running the model. The non-negative difference in the two objective functions, divided by $Y_{k(w),v}$, is the opportunity cost for that limitation type for that resource.

The next section provides illustrative examples on how the model will be used to determine the initial opportunity cost, and how the opportunity cost will be updated as the year progresses.

7.5 Examples of Opportunity Cost Model

The following examples are intended to better illustrate how the model will be utilized to determine opportunity costs for various limitations, and combinations thereof. It also serves to provide clarity as to how the limitations will be set and run in each model.

Example-1 through Example-4 below illustrate how the model will determine the opportunity cost for fixed-annual and monthly limitations, as well as updating the opportunity costs as the year progresses.

Note, that if a resource only has a fixed-annual limitation, **Example-1 and Example-2** will still apply without the monthly limitation in the model. If a resource only has a monthly limitation, **Example-3 and Example-4** will still apply without the fixed-annual limitation.

Example-5 and Example-6 illustrate how the model will determine the opportunity cost for nested limitations. Nested limitations refer to limitations of the same type, e.g., start, but over different time horizons, e.g., fixed-annual and monthly.

Example-7 and Example-8 illustrate how the model will determine the opportunity cost for a rollingannual limitation.

Note:

Also, refer to Appendix-6 for a numerical example of opportunity cost calculations for non-MSG resources, and Appendix-7 for MSG resources.

7.5.1 Example-1: Calculating the Opportunity Cost for Fixed-Annual Start Limitation (Overlapping with Monthly Run-Hours Limitation)

For each limitation type (starts, run hours or output) that has fixed-annual limitation (under analysis) (still can have monthly limitation for another limitation type), system shall perform two model runs one month before the applicability start month, for resources with "fixed-annual limitation".

For example:

- For fixed-annual plan applicability from March 1, 2018-February 28, 2019, initial model run shall be run on any day within February 2018.
- The model run analysis time horizon shall cover March 1, 2018 February 28, 2019 (12 months).


System shall calculate the opportunity cost **for each limitation type** for the following fixed 12 months (March 2018-February 2019 for the above example) as the difference between Model_Run_1 and Model_Run_2, divided by $Y_{k,v}$, where:

- Model_Run_1 (base B-run) would reflect
 - a) Fixed-annual limitation for that limitation type under analysis
 - b) Any fixed-annual limitation and monthly limitations for all calendar months for other limitation types
- Model_Run_2 (L-run) would reflect
 - a) $Y_{k,v}$ less fixed-annual limitation for that limitation type under analysis
 - b) Any fixed-annual limitation and monthly limitations for all calendar months for other limitation types

Notes:

- There will be two model runs that covers the fixed-annual applicability under analysis where opportunity cost needs to be modeled (March 2018-February 2019 for the above example).
- Modeled opportunity cost for fixed-annual limitation is applicable to each month of the following fixed 12 months (March 2018-February 2019 for the above example).

Attachment G of the Market Instruments Business Practice Manual specifies how proxy costs are calculated for non-gas fired resources. To be consistent with those calculations, the cost estimates for non-gas fired resources used in the opportunity cost model will also be based on those calculations.
