## COMMENTS OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

Pursuant to the Commission's February 3, 2004 Notice of Filing, the California Independent System Operator Corporation (ISO) submits its comments in response to the January 28, 2004 filing of Gilroy Energy Center, LLC (Gilroy) of substitute rate schedule sheets to its December 22, 2003 filing of revisions to the Reliability Must-Run (RMR) Agreement between Gilroy and the ISO for calendar year 2004. In response to Gilroy's December 22, 2004 filing, the ISO and Pacific Gas and Electric Company (PG&E) filed a joint provisional protest identifying seven outstanding issues that Gilroy, the ISO and PG&E had yet to resolve. Although these seven issues have now been resolved and the ISO has executed the RMR Agreement, the ISO has identified the following four errors in Gilroy's January 28, 2004 submission:

- 1. Sheet No. 138, at note "\*\*\*", insert a space between "for" and "Unit 1".
- 2. Sheet No. 145, at note "\*\*", strike the words "the weighted average of" and replace "values" with "value" in the second half of the sentence so that the entire phrase reads: "otherwise the value will be equal to the combined Unit 1 & 2 value."
- 3. Sheet No. 226, delete extra "." In the last line of the second to last paragraph.

4. Sheet 227, the formula for UD(i) in the fifth paragraph below the table, delete, "ED(i)" and replace it with "UD(i)".

Three of the four errors are typographical. The second error relating to Sheet No. 145, is substantive, but relatively minor, and Gilroy has advised the ISO that it will submit an errata filing reflecting all four changes.

Accordingly, the ISO requests that the Commission accept the revisions to the RMR Agreement reflected in Gilroy's December 22, 2003 submission as revised by its January 28, 2004 filing, subject to the forthcoming errata filing correcting the errors identified by the ISO in these comments, effective as of January 1, 2004.
