> > Notice of Cancellation of EIM Implementation Agreement with NV Energy

Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO) submits for Commission acceptance this notice of cancellation of the Energy Imbalance Market (EIM) Implementation Agreement between the CAISO and Nevada Power Company d/b/a NV Energy, a Nevada corporation and Sierra Pacific Power Company d/b/a NV Energy, a Nevada Corporation (collectively, "NV Energy") (Implementation Agreement). The CAISO is cancelling the Implementation Agreement in accordance with its terms, because the tariff revisions and service agreements needed to implement NV Energy participation in the EIM have gone into effect.

The CAISO requests that the Commission accept this notice of cancellation effective 61 days after the date of this filing, i.e., February 19, 2018.

#### I. **Background and Basis for Cancellation**

In 2014, the Commission accepted for filing the CAISO's submittal of the Implementation Agreement and granted the CAISO's requested effective date of June 16, 2014.<sup>2</sup>

The CAISO submits this filing pursuant to Section 35.15 of the Commission's regulations, 18 C.F.R. § 35.15. The Implementation Agreement is designated as CAISO Rate Schedule No. 76.

Section 1(d) of the Implementation Agreement states that the agreement shall terminate upon the earliest of any of several specified events that include "the date FERC permits all necessary revisions to NV Energy tariff to take effect and the service agreements under such tariff and the ISO tariff necessary for the commencement of the EIM have taken effect." The events described in the quoted provision of the Implementation Agreement have occurred.<sup>3</sup>

For these reasons, the Implementation Agreement is no longer needed and has terminated. Therefore, the CAISO requests that the Commission accept this notice of cancellation effective 61 days after the date of this filing, *i.e.*, February 19, 2018.
