Request for Privileged Treatment Under 18 C.F.R Section 388.112

Dear Secretary Bose:

Pursuant to Section 39.7.1.3.2 of its tariff, the California Independent System Operator Corporation submits this informational filing containing the rates or formulas used to calculate negotiated default energy bids and major maintenance adders that were implemented or modified in the month of November 2013. This is the first month where major maintenance adders have been allowed to be included as components of start-up or minimum load costs. Accordingly, the bulk of this filing consists of major maintenance adders. This fling also includes some modified negotiated default energy bids. No information is being submitted relating to customer operations and maintenance adders.

I. REQUEST FOR CONFIDENTIAL TREATMENT

Section 20.2 of the ISO tariff requires that the ISO treat individual bids from scheduling coordinators as confidential. Negotiated default energy bids and start-up and minimum load costs are components of bids. Accordingly, pursuant to section 20.2 of the ISO tariff, the ISO has labeled the documents included with this filing as confidential. In addition, many of the documents contain proprietary information regarding specific generating units, such as unit efficiency factors, scaling factors, and operation and maintenance costs. For these reasons, the Commission should accord these attachments privileged treatment pursuant to 18 C.F.R. Section 388.112.

On October 29, 2013, the Commission accepted the ISO's tariff amendment permitting major maintenance adders to be included in start-up or minimum load costs. *California Indep. Sys. Op. Corp.*, 145 FERC ¶ 61,082 (2013).
