MOTION FOR EXTENSION OF TIME OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION TO FILE INFORMATIONAL REPORT

The California Independent System Operator Corporation (CAISO)¹ respectfully requests an extension of time to file one of the two monthly informational reports that the Commission directed the CAISO to file in its September 2, 2009 order,² as modified by its May 4, 2010 order.^{3, 4} On the 30th of the month, the CAISO files the version of the monthly Exceptional Dispatch report that includes Chart 2 data. Chart 2 includes a detailed summary of the costs of the exceptional dispatches for the reporting month, as well as the market impact and degree of mitigation analysis.

Due to software problems, the CAISO was unable to generate the Chart 2 version of the settlements summary for the exceptional dispatches occurring in the

month of August 2016. Accordingly, the CAISO was not able to submit the Chart 2

Exceptional Dispatch report on November 30, 2016.

The CAISO respectfully requests an extension of time to file the Chart 2 version

of the Exceptional Dispatch report for August 2016, and the Chart 2 version of the report

for September 2016, to January 30, 2017. The CAISO hopes it will be able to remedy

the problem sooner, in which case, the CAISO will file the reports when available. The

problem that the CAISO is having does not affect the Chart 1 Exceptional Dispatch

reports filed on the 15th of every month. The CAISO will continue to file the Chart 1

version of the reports on time.
