## JANUARY 2007 STATUS REPORT OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

The California Independent System Operator Corporation ("CAISO") respectfully submits this monthly progress report ("Report") in compliance with Paragraph 1415 of the Commission's September 21, 2006 "Order Conditionally Accepting The California Independent System Operator's Electric Tariff Filing To Reflect Market Redesign and Technology Upgrade," 116 FERC ¶ 61,274 (2006) ("September 21 Order"), issued in the above-referenced docket.

The September 21 Order requires the CAISO to file monthly reports concerning the progress in designing and implementing the CAISO's Market Redesign and Technology Upgrade ("MRTU") and, as required by P 1415 of the September 21 Order, on the CAISO's MRTU readiness program. The CAISO will continue to file this monthly report on the first Monday of the month through the implementation of MRTU, currently slated for January 31, 2008 following the California Board of Governor's December 19, 2006 decision to extend the implementation date.

The monthly report contains two attachments: Attachment A includes the following elements as previously provided: (1) detailed timeline with the sequential and concurrent nature of the design elements; (2) cost estimates for

each element; (3) progress report; (4) accomplishments/milestones; and (5) planned activities<sup>1</sup>. Attachment B addresses the development of both the CAISO and market participant readiness criteria. The information contained in Attachment B reflects the current status of the CAISO's MRTU Readiness Program.<sup>2</sup>

Highlights related to MRTU implementation identified in Attachment A include: (1) CAISO Board of Governors decision on December 19, 2006 resulting in revised scope, schedule and budget increase and an extension of the implementation date for Release 1 MRTU from November 2007 to January 31, 2008; (2) Congestion Revenue Rights – Tier III allocation results published, and Yearly Auction Bid conducted and results posted; (3) multiple Build activities completed as part of integration; (4) progress made in Functional Integration Testing; (5) SaMC – first set of Charge Codes for testing delivered; (6) Full Network Model and State Estimator – onsite testing of database 1 regression completed; (7) Integrated Forward Markets – fourth week of Analysis Track phase 2 completed; and (8) Market Quality Systems – all test cases for Site Acceptance Test passed.

Highlights on status of readiness activities included in Attachment B: (1)
Readiness Criteria posted to CAISO Website on December 19, 2006<sup>3</sup>; (2) 37 on-



## **MRTU Executive Summary**

Over the past month, MRTU has moved closer towards implementation with many MRTU projects steadily achieving their development, testing, and delivery milestones.

The month's primary System Development, and Functional and Site Acceptance Testing accomplishments include: Congestion Revenue Rights (CRR) published Tier III allocation results, and closed, ran, and posted Yearly Auction Bid results; Full Network Model and State Estimator (FNM/SE) completed onsite testing of DB1 and continued model development updates. Integrated Forward Markets (IFM) completed its fourth week of Analysis Track Phase 2; Settlements and Market Clearing (SaMC) is planning to deliver Charge Codes for testing and complete Business Associate Portal Phase 2 testing by the end of the year. Projects continue to progress with Site Acceptance Testing (SAT) and meet appropriate exit criteria; several applications have progressed with Functional Acceptance Testing (FAT) and continue to transfer into Application Integration Testing (AIT).

Concurrently, the Program Management Office (PMO) has made strides by completing a Budget Mitigation Analysis, drafted a Configuration Management Plan, and is evaluating impact of the FERC order. The Integration team completed many Build activities while transitioning work to Quality Assurance and AIT/Functional Integration Testing (FIT). Project teams continue to collaborate with the Integration and Integration Testing teams to synchronize development and delivery efforts against the new release plan.

MRTU development, testing, and integration efforts continue to approach many milestone completions. The PMO continues to analyze budget lever and cost pressures for the entire project.










## **Program Key Metrics**


