**Meeting Objective:** To have a focused discussion clarifying and evaluating the merits of

certain design elements/issues associated with the specific long-term resource adequacy design proposals submitted to the CPUC Phase 2,

Track 2 Resource Adequacy Initiative.

**Meeting Format:** After a brief overview by CPUC staff on the schedule and scope of the

Phase 2-Track 2 proceeding, the meeting will be structured in a panel format consisting of representatives from each of the five proposals submitted to the CPUC (Constellation, Mirant, California Forward Capacity Market Advocates (CFCMA), PG&E, and Bilateral Trading Group). This

meeting will focus on why changes to the current RA process are

necessary. The goal is to identify features that must be part of any LT-RA process and clarify the tradeoffs that exist between these features. To this end, the Proposed Objective/Vision section of the meeting will ask each panelist to identify the deficiencies and strengths of the current LT-RA process. MSC members will use the subsequent question and answer session to help identify remedies for these deficiencies and tradeoffs that

exist between them.
