## ORDER GRANTING REHEARING FOR FURTHER CONSIDERATION

Rehearing has been timely requested of the Commission's order issued on October 11, 2002, in this proceeding. <u>Revision of Annual Charges to Public Utilities</u> (California Independent System Operator, et al.), 101 FERC ¶ 61,043 (2002). In the absence of Commission action within 30 days, the request for rehearing (and any timely requests for rehearing filed subsequently)<sup>1</sup> would be deemed denied. 18 C.F.R. § 385.713.

In order to afford additional time for consideration of the matters raised or to be raised, rehearing of the Commission's order is hereby granted for the limited purpose of further consideration, and timely-filed rehearing requests will not be deemed denied by operation of law. Rehearing requests of the above-cited order filed in this proceeding will be addressed in a future order. As provided in 18 C.F.R. § 385.713(d), no answers to the rehearing requests will be entertained. The Commission anticipates issuing an order on the merits in this proceeding by February 24, 2003.
