On December 30, 2019, the California Independent System Operator Corporation (CAISO) filed an executed Transferred Frequency Response Agreement (Agreement) with Bonneville Power Administration. The Agreement specifies the rates, terms, and conditions under which Bonneville Power Administration will provide transferred frequency response to CAISO. Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted, and the Agreement is accepted for filing, effective January 1, 2020, as requested.

This filing was noticed on December 30, 2019, with comments, protests, or motions to intervene due on or before January 20, 2020. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.
